What is the STCW Code

The STCW (International Convention on Standards of Training, Certification and Watchkeeping for Seafarers) sets the global minimum qualification standards for masters, officers, and watchkeeping personnel on seagoing vessels and large yachts. Established in 1978 by the International Maritime Organization (IMO), the convention ensures standardised training worldwide, with key updates introduced in 1995 (STCW 95) and the 2010 Manila Amendments.

Basic Safety Training under STCW is a mandatory requirement for anyone seeking to work on commercial ships, ferries, cruise ships, or superyachts. STCW certifications are typically valid for five years, after which refresher training is required. Stream Marine Training provides both initial and refresher STCW courses, detailed within this brochure.



Who are SMT

Stream Marine Training are the UK's leading and largest maritime training provider. We are expanding our business into the renewables and oil & gas industry. Basic Safety Training Course

The STCW Basic Safety Training is a mandatory programme for all seafarers working on commercial vessels. It covers four core modules — **Personal Survival Techniques, Fire Prevention and Fire Fighting, Elementary First Aid, and Personal Safety and Social Responsibilities** — with a fifth module, **Proficiency in Security Awareness**, included in our syllabus at SMT. This five-day course equips participants with the essential skills to respond effectively in emergencies and meet international legal requirements for working at sea.
